1. Call Special Town Meeting to order.
The meeting was called to order at 6:00 pm.

2. Call Public Hearing to order to review the 2017 Town budget.

Motion by Andy Peters, second by Dean Culbertson to close the Public Hearing. Motion carried unanimously. Public Hearing closed at 6:01 pm.
4. Resolution to approve the total 2017 highway expenditures pursuant to section 81.01(3) WI Statutes.
Motion by Jack Anderson, second by Dean Culbertson to remove item #4 as it is not needed. Motion carried unanimously.
5. Resolution to adopt the 2016 tax levy to be paid in 2017 pursuant to section 60.10(1)(a) WI Statutes.
Town Administrator Dave Tebo provided a summary of the Town Budget. Motion by Dean Culbertson, second by Jack Anderson to approve the 2016 tax levy to be paid in 2017. Motion carried unanimously.
6. Establish Elected Officials salaries for 2017-19 Board members pursuant to Sec 60.32 of WI Stats.
Motion by Tom Becher to make the two Town Board Supervisor positions to be elected in April 2017 be the same wage as the other two Town Board Supervisor positions at \$390.17/mo., and the Town Chairman wage to be double what the supervisors are being paid, \$780.34/mo., second by Tim Lambie. Motion carried unanimously. The \$35 per diem will remain the same.
